- ✓ Sets out the key initiatives for the year ahead.
- ✓ Informs the European institutions, Member States, citizens and stakeholders how the Commission delivers on the political priorities and turns them into concrete action.

- ✓ 18 July 2024: Candidate for Commission President von der Leyen presents her 2024-2029 Political Guidelines
- ✓ 17 September 2024: President-elect von der Leyen presents future College and sends mission letters to Commissionersdesignate

## 2025 work programme focus: 'Moving forward together: A Bolder, Simpler, Faster Union'

#### ✓ Main focus of the 2025 Commission work programme

- > Boosting competitiveness, enhancing security, and bolstering economic resilience
- Initiatives for the first year of the mandate that reflect the need for more opportunities, innovation and growth for our citizens and businesses.

#### ✓ Simplification

> Strong focus on making the implementation of EU rules easier in practice, reduce administrative burdens and simplify EU rules.

#### ✓ Strategies framing the way ahead

Apart from first key legislative proposals, the Commission work programme lists several key strategies that outline the way forward on competitiveness, social policy, democracy and the EU's global role.

## 2025 Commission work programme: Figures

- ✓ 51 new initiatives, of which 18 legislative, of which 11 simplification initiatives
- √ 37 evaluations and fitness checks
- ✓ 123 key proposals already adopted by the Commission and to be agreed into law
- √ 37 initiatives proposed for withdrawal;
- √ 4 repeals proposed
