Segment 1: EBO Support to EU Business Competitiveness

Duration: 20 minutes

This roundtable will delve into how European Business Organisations (EBOs) in Africa can concretely enhance EU business competitiveness across the continent. The discussion will highlight EBOs' pivotal role in facilitating targeted business missions, fostering strategic partnerships, and providing real-time market intelligence to European companies. Participants will explore how EBOs can better align their support services with key EU instruments—such as the Global Gateway and NDICI funding—ensuring that businesses can access and benefit from available opportunities. Additionally, the session will examine ways to foster diaspora entrepreneurship and leverage transnational business networks to drive innovation, investment, and value-added trade between the EU and Africa.

Key Discussion Points:

- Examining how European Business Organisations (EBOs) can enhance EU business competitiveness across Africa.

Segment 2: Enhancing Public-Private Dialogue, Cooperation and Business Advocacy

Duration: 20 minutes

This roundtable will focus on two interlinked priorities: enhancing public-private dialogue and business advocacy, and strengthening the role of European Business Organisations (EBOs) in EU-Africa trade and investment. The discussion will explore the establishment of a structured EU-EBO dialogue platform to facilitate ongoing regulatory feedback, identify and address trade and investment barriers, and support advocacy on policy coherence.

Participants will also examine how EBOs can proactively contribute to the EU's trade and investment agenda across Africa by improving market intelligence, supporting sustainable business environments, and enabling access to EU instruments such as the Global Gateway. A particular focus will be placed on capacity-building initiatives and risk mitigation strategies to ensure European businesses can operate effectively and sustainably in diverse African markets.

Key Discussion Points:

- Focus on enhancing public–private dialogue and business advocacy.
- Establish a structured EU–EBO dialogue platform for regulatory feedback and addressing trade barriers.
- Support joint advocacy on policy coherence between the EBOs in Africa.
- Strengthen EBO contributions to the EU's trade and investment agenda in Africa.
- Improve market intelligence and sustainable business environments for European companies.
- Enable access to EU instruments like the Global Gateway for African trade and investment.
- Prioritise capacity-building initiatives and risk mitigation strategies.



Segment 3: Leveraging the Global Gateway

A brief presentation will showcase available tools and upcoming programmes aimed at strengthening public-private collaboration, enhancing EBO capacity, and connecting European businesses with sustainable growth sectors in Africa.

The roundtable will then focus on the role of European Business Organisations (EBOs) in supporting the implementation of the EU's flagship initiatives—namely the Global Gateway and the European Green Deal—across African markets. Furthermore, the diagnostic and the EABF EBOWN collaboration to strengthen EBO's in African capacity to partner with EU initiatives and forums. The discussion will examine how EBOs can serve as vital intermediaries in disseminating information, guiding companies through access to funding and partnership opportunities, and promoting alignment with green investment and digital transition objectives.

- 7. How can stronger partnerships—with EU Delegations, African BSOs, or other EBOs—better support your mission?
